


1. Background

- 1.1. Having regard to the Letter of Intent concerning the establishment of the Alpine-Western Balkan Rail Freight Corridor signed by the Ministers in 2015 which clearly expressed the political will of the sides to establish the "Alpine-Western Balkan" Rail Freight Corridor;
- 1.2. Having regard to the ministerial Letter of Intent (LoI) of the respective Ministries of Austria, Slovenia, Croatia, Serbia and Bulgaria signed on 7th of November 2017 by the State Secretaries of the Member States of the Alpine-Western Balkan Rail Freight Corridor on the route

Salzburg - Villach - Ljubljana - /
Wels / Linz - Graz - Maribor Zagreb - Vinkovci / Vukovar - Tovarnik - Beograd - Sofia - Svilengrad (Bulgarian-Turkish border);

- 1.3. Having regard to the adoption of the Regulation (EU) No 913/2010 (hereinafter referred to as "the Regulation") by the European Parliament and the Council on 22 September 2010 concerning a European rail network for competitive freight, entered into force on 9 November 2010, amended by the Regulation (EU) No 1316/2013;
- 1.4. Having regard to the definition of "freight corridor" laid down in the Regulation;
- 1.5. Having regard to the provisions of the Regulation for the selection of further freight corridors;
- 1.6. Having regard to the necessity of coordinated development of the networks;
- 1.7. Having regard to the responsibilities of the Management Board, as described in the Regulation;
- 1.8. Having regard to the perspective of the rail transport system as the sustainable transport system in Central and South Eastern Europe;

1.9 Having regard to the importance of advance transport infrastructure interconnections between EU Member States and their neighbouring countries, in particular the connections of EU Member States crossing the territories of neighbouring countries that are candidates for the accession to the European Union.

2. Establishment of the Management Board

2.1. The Parties hereby establish the Management Board of the Alpine-Western Balkan Rail Freight Corridor as defined by the Regulation (EU) 913/2010:

Salzburg -Villach - Ljubljana - /

Wels / Linz - Graz - Maribor -

Zagreb - Vinkovci / Vukovar - Tovarnik - Beograd - Sofia - Svilengrad (Bulgarian-Turkish border);

2.2. Each Party shall appoint, by the Letter of Appointment, one representative as well as a deputy representative for the Management Board not later than three months after the adoption of the MoU by all involved parties.

3. Objectives and principles of the Management Board

The Management Board has to operate the corridor as defined in Regulation (EU) 913/2010. This shall include, among others, the following tasks:

- 3.1. Creating the organizational, technical and operational conditions to make the Alpine-Western Balkan Rail Freight Corridor operational according to Article 5(7) of the Regulation;
- 3.2. Developing the attractiveness of the corridor in terms of performance, traffic management, quality and Marketing promotion, all backed by a "market oriented" approach;
- 3.3. Committing to cooperate at a high level to fulfil the requirements of the Regulation, in particular:
 - Defining the organizational structure and working and decision-making procedures of the Management Board;
 - Setting up the Advisory Groups as prescribed in the Regulation;
 - Setting up the Corridor One-Stop-Shop (C-OSS);
 - Determining its legal status.

4. Organization and decision making process of the Management Board

- 4.1. The Management Board consists of designated representatives of the following Infrastructure Managers: ÖBB-Infrastruktur AG, SŽ-Infrastruktura, d.o.o., HŽ INFRASTRUKTURA d.o.o., Infrastruktura železnice Srbije a.d. and National Railway Infrastructure Company;
- 4.2. Each Party may appoint one permanent member of the Management Board with a standing delegation of power and one substitute member, who shall act as a replacement for the permanent representative;
- 4.3. Each Party has a right to change its designated representative to the Management Board. Appointment of a new member results in the termination of the mandate of the previously appointed representative of the Party, with immediate effect;

- 4.4. The Management Board of the Alpine-Western Balkan Rail Freight Corridor shall decide on all issues of common interest concerning the implementation of the Rail Freight Corridor in accordance with the Regulation;
- 4.5. The Management Board of the Alpine-Western Balkan Rail Freight Corridor shall take all its decisions on the basis of mutual consent of its members.

5. Final provisions

- 5.1. This Memorandum of Understanding shall enter into force upon its signature by the authorized representatives of all Parties and shall remain in force for an indefinite time period;
- 5.2. This Memorandum of Understanding may be modified, amended or supplemented only on the basis of mutual consent of the Parties. Any changes shall be made in an Annex to this Memorandum and shall function as an integral part of the Memorandum of Understanding;
- 5.3. This Memorandum of Understanding has been drawn up in 6 original counterparts, of which each Party receives 1 original document and 1 is kept by the Secretariat/PMO together with 5 original Letters of Appointment.
